The PM SHRI School must satisfy the following conditions:

Classroom:

- Classrooms should be well-ventilated.well-lit,and spacious enough for all students to sit comfortably.
- The floor,walls,and ceilings of the PM SHRI School classrooms should be kept in good condition.

Science Laboratory;

- The science laboratory should be well-equipped with instruments,safety features,and organized storage for chemicals and equipment,with ample space and proper ventilation.

- Clear guidelines for safety and cleanliness should be in place to create an environment conducive to scientific inquiry.

Library

- Library should be well furnished with table, chairs and shelf to keep the books.
- A register should be maintained and books should be issued regularly to every child studying in the school.
- The library should have sufficient number of age-appropriate books on all subjects in its stock
- Books should include e-Books, Fiction, Non-fiction, Reference Books, Encyclopaedia, Periodicals, Magazines, Journals and Newspapers. Staff and students should be encouraged to read e-magazines, e-journals, e-books etc.
- The library shall issue books regularly to every child studying in the school. Adequate budgetary provisions must be made for the School Library.

Computer Laboratory

- The school should have internet connectivity with good speed.
- If the school is offering any subject related to Computer Science or IT at Senior Secondary level, it should have a separate laboratory with adequate provisions for the same. There should be adequate provisions related to cyber safety in the computer laboratory and students should be allowed in the laboratory only under the supervision of a teacher.

Drinking water, Toilets and other Facilities and Other Physical Facilities

- The school shall provide adequate facilities for drinking water on each floor.
- The school will provide clean healthy and hygienic toilets on each floor with washing facilities for boys and girls separately in proportion to the number of students. The toilets for the primary students should be separate from other toilets. There should be separate toilets for staff members. Signage Boards should be displayed prominently on the toilets of all categories.
- The school shall provide proper facilities like ramps in toilets and at entry/exit points for wheelchair users and auditory signals with the provisions laid down in RPWD Act-2016.
- The school should have suitable furniture in the classrooms commensurate with the strength of students and staff.
- The school should have the needed equipment and facilities as per the syllabus prescribed for Sciences, Home Science, Technical subjects, Vocational subjects and various activities under Work Experience and Art Education etc.
- The school shall observe prescription from the State Government/Municipal Authority/Transport Department regarding health & hygiene, drinking water, fire safety, building safety and transport precautions in the school.

- The school should have adequate facilities for providing recreational activities and physical education as well as for conduct of various activities and programs for developmental education and for the social,cultural and emotional and ethical development of the students and for safeguarding their health.

Play Ground:

- The school should have adequate ground to create outdoor facilities and also facilities for kabaddi,kho-kho,volleyball,basketball etc.

Enrolment And Section Restriction in Each Class:

- Availability of one square meter built-up floor Area per child in the classrooms is an absolute necessity in the school.Subject to this,the details of the allowed sections as per the rules of these byelaws and availability of land and infrastructure

Rights of Persons with Disabilities

- School will provide proper facilities like ramps in toilets for wheel chair users,auditory signals in elevators/lifts and other possible infrastructural facilities in accordance with the provisions laid down in RPWD Act-2016.
